#### **Terms and Conditions**

#### **PERMITS**

Any horses that are stabled at the Rodeo Grounds for more than two (2) weeks must have a permit per animal or be registered to the Town Common.

#### RACE COURSE RESERVE (RODEO GROUNDS)

- Horses are permitted to free-range during daylight hours on the Racecourse paddock. They must be yarded or stalled overnight.
- The fenced area adjacent to the Race Course Reserve is deemed to be a paddock for the short term holding of horses and separate application must be made to keep horses in the paddock.
- The maximum number of horses allowable at the Rodeo Grounds at any one time will be at the discretion of the RLO.
- Transfer of horses between the Thargomindah town common and the Rodeo Grounds will be managed by the RLO and carried out on application by the owner of horses being agisted on the common.
- The total number of horses allowed to stabled at the Rodeo Grounds per owner is 5 (including foals), however the number permitted per owner may be reduced depending upon the number of owners wishing to stable horses at the Rodeo Grounds.
- The gates to the Horse Holding Paddock are to be locked at all times.
- No Stallions are allowed to be stabled at the Rodeo Grounds or on the Race Course Reserve
- The Applicant is to remove horse/s from the Rodeo Grounds/Racecourse Reserve if and when directed by an authorised person.
- Any animal welfare concerns will be reported to Department of Agriculture, Forestry and Fisheries for further investigation.
- Should the horse owner no longer reside in Thargomindah then they are required to remove all horses from the Rodeo Grounds
- All horses are to be removed within two (2) weeks of the owner leaving. The owner must notify Council prior to removing the stock.
- Any horses at the Rodeo Grounds which do not have a permit or are not registered to the Thargomindah Town Common will be deemed to be straying stock and impounded in accordance with Council's Local Law. This does not apply to horses that are stabled at the Rodeo Grounds during an organised event.


### **FEES**
