ELIGIBILITY FOR PENSIONER RATE CONCESSION

For an applicant/s to obtain the Pensioner Rate Concession, they need to comply with the following conditions:

1. Applicant/s must be in receipt of and remain an eligible holder of a:
Queensland Pensioner Concession Card,
(Issued by Centrelink or the Department of Veterans' Affairs)
OR
Queensland Repatriation Health Card – For All Conditions (Gold)
(Issued by Department of Veterans' Affairs)
2. Applicant/s must **reside** on the property for which the concession is claimed and be the **registered owner/s, or life tenant/s***, either solely or jointly, of a property which is his/her principal place of residence.
(Part ownership will be eligible according to the percentage of ownership held in the property).

*** A life tenancy can be created only by a valid will, and is effective only after the death of the property owner.**

DOCUMENTATION TO ACCOMPANY APPLICATION

The following documents must be supplied with this application form:

1. Queensland Pensioner Concession Card **OR** Queensland Pensioner Repatriation Health Card – For All Conditions (Gold) – **for each applicant**
 - To be sighted by Council Staff on submission of application **OR**
 - A photocopy of the relevant card to accompany the application
2. **Life Tenant** applicants **must produce** the original Will or Court Order as well as the above documents. There must not be provision in the Will or Court Order which would relieve the Life Tenant of the obligation to pay rates and charges in respect of the property.

STATE GOVERNMENT/COUNCIL PENSIONER RATE SUBSIDY

The State Government Pensioner Rate Subsidy is 20% of gross rates and charges (excluding fire levies) to a maximum of \$200.00 per annum.

The Bulloo Shire Council Pensioner Rate Subsidy is 20% of gross rates and charges to a maximum of \$200.00 per annum.
