Title

1. This notice may be cited as Bulloo Shire Council (Making of Local Law) Website Notice (No. 1) 2019.

Commencement

2. This notice commences on the date it is published on the website of Bulloo Shire Council.

Making of local laws

- 3. Bulloo Shire Council (the "Council") has, by resolution dated the 16th day of July 2019, made local laws, which incorporate model local laws, as follows—

Model local laws incorporated

Local laws that contain an anti-competitive provision
